

Bromelain-POS®

Dear Patient:

Please read this leaflet carefully because it contains important information for you. If you have further questions, please ask your physician or your pharmacist.

Bromelain-POS®:

Active ingredient: Bromelaine

Composition:

1 gastro-resistant tablet contains:

Active ingredient:

Bromelaine 500 F.I.P. units (equivalent to 67-100 mg of bromelaine)

Other Ingredients:

Microcrystalline cellulose, crospovidone, magnesium stearate, colloidal silica, eudragit L, diethyl phthalate, talc and triethyl citrate.

Pharmaceutical form and pharmaco-therapeutic group:

Gastro-resistant tablets for an antiphlogistic and anti-oedematous treatment.

Therapeutic Indications:

Acute post-operative and post-traumatic swellings especially of the nose and the paranasal sinus. Please contact the doctor if the symptoms continue unchanged for more than 4 weeks.

Contraindications:

Do not use in known hypersensitivity to bromelaine (ananas).

Bromelain-POS® should not be given to children younger than 12 years because not enough examinations are available.

Precautions for Use:

Special Warnings:

None

Interactions:

Bromelain-POS® increases the plasma and urine level of tetracycline (antibiotics).

Bromelain-POS® should not be given to patients taking drugs for controlling the blood coagulation (anti-coagulant) and/or anti-thrombotic agents.

Instructions for proper use:

If not otherwise prescribed, take 1 tablet 3 times daily.

The tablets are resistant to gastric acid and should not be chewed. They should be taken 30 minutes before meal with liquid.

Usually the duration of therapy is 8 -10 days; in justified cases the application over a longer period is possible.

In rare cases gastric disorder, diarrhoea and allergic reactions

Storage instructions:

To be stored at room temperature (below 25°C).

Bromelain-POS® should not be used beyond the expiration date (imprinted on the packaging carton)
