LUBRICANT EYE DROPS WITH SODIUM HYALURONATE

INDICATIONS

For prolonged relief of discomfort due to minor irritations of the eye from exposure to wind, sun, water or other irritants. For use as a lubricant and protectant **at bed time** against further irritation or to relieve dryness of the eye.

DIRECTIONS

Wash hands before use. Check that the single-dose container is not damaged. Do not use after the expiry date. Do not use single-dose container more than once. Instill 1 or 2 drops in the affected eye(s) as needed. While looking in a mirror, gently pull down lower eyelid and instill 1 or 2 drops on its inner surface or apply 1 or 2 drops directly to the corneal surface of the eye by leaning head back to a horizontal position.

CONTAINS

I-Drop[®]PM is a sterile lubricant eye drop and contains no preservatives. Each mL contains:

Sodium hyaluronate	3.0 mg
Sodium chloride	8.5 mg
Sodium phosphate monobasic	0.28 mg
Sodium phosphate dibasic	0.04 mg
Water for injection	q.s.

WARNINGS

If you experience eye pain, change in vision, continued redness or irritation of the eye, or if the condition worsens or persists for more than 72 hours, discontinue use and consult a doctor.

I-Drop[®]PM may modify the effect of other solutions or drugs that you may be using on the eye.

This product has not been tested during pregnancy or lactation.

KEEP OUT OF REACH OF CHILDREN

Do not apply **I-Drop[®]PM** on an infected eye. Do not operate machinery or drive a vehicle immediately after use. To avoid contamination do not touch tip of container to any surface. Do not use this product if you are allergic to any of the ingredients. **Blurring of vision results after application. For bed time use.**

HOW SUPPLIED


I-Drop[®]PM is supplied in a single-dose container with a fill volume of 0.3 mL. Each box contains 20 single-dose containers. Preservative free. Do not use if the safety seal on outer box is damaged.

Store at or below 25°C. Prevent from freezing. Protect from sunlight.
