# 1. What HYDROCORTISONE MEDIS 100 mg is and what it is used for

HYDROCORTISONE MEDIS 100 mg is a drug composed by an active substance, the Sodium Hydrocortisone succinate. This specialty belongs to the pharmaco-therapeutic class: Glucocorticoid Hormone

This drug is indicated in the treatment of adrenal insufficiency (diminution or absence of secretion of the hormones secreted by the adrenal glands), transient adrenal insufficiency of the newborn, congenital Hyperplasia of the adrenal glands with salt loss syndrome (syndrome of Debré-Fibiger)

# 2. Before you take HYDROCORTISONE MEDIS 100 mg Do not take HYDROCORTISONE MEDIS 100 mg

If you are allergic (hypersensitive) to the sodium hydrocortisone succinate or to one the composents of HYDROCORTISONE MEDIS 100 mg.

In case of doubt, it is necessary to ask your doctor or pharmacist advice.

# Take special care with HYDROCORTISONE MEDIS 100 mg

Diet: it is imperative to continue a normal salt diet in the case of adrenal insufficiency

The oral or injectable corticoids can favor the occurrence of tendinopathies, and even tendon rupture (exceptional). Prevent your doctor in case of appearance of tendon pains.

Rapidly inform your doctor about any aggression factor (fever, infection, disease, surgical intervention, traumatism), because this may require a dose increase

In case of doubt, it is necessary to ask your doctor or pharmacist advice.

# Taking HYDROCORTISONE MEDIS 100 mg with other medicines

If you take or you have recently taken other drugs, even those obtained without medical prescription, inform your doctor or your pharmacist.

# If you discontinue HYDROCORTISONE MEDIS 100 mg

Ask your doctor advice before discontinuing the use of HYDROCORTISONE MEDIS 100 mg

#### 4. Possible side effects

Like all the other drugs, HYDROCORTISONE MEDIS 100 mg can provoke undesirable effects. However, all the patients will not experience these effects. - Some cases of tendons ruptures were exceptionally reported, especially in case of concomitant prescription of Fluoroquinolones

Rare cases of general allergic reactions.
