- Stenosis (narrowing) of the gastro-intestinal tract.

4. HOW TO USE THIS MEDICINAL PRODUCT

DOSAGE:

Oral route

Adults: the usual dose is 3 sachets per day.

Children: under 2 years: 1/2 sachet 1 to 2 times per day;

2 to 5 years : 1/2 sachet 2 to 3 times per day;

5 to 10 years : 1 sachet twice per day.

Rectal route

Retention enema: 1 to 3 enemas per day of 1 to 3 sachets mixed with 100 ml of water.

METHOD AND ROUTE OF ADMINISTRATION:

Oral route

The contents of one sachet may be stirred into half a glass of water or mixed with a semi-liquid food such as porridge, stewed fruit, mashed potato, etc.

Rectal route

The contents of one or more sachets may be mixed with 100 ml of warm water.

FREQUENCY AND TIME AT WHICH THIS MEDICINAL PRODUCT SHOULD BE ADMINISTERED:

Preferably take between meals or just before a meal.

DURATION OF TREATMENT:

Take as directed by your doctor.
