## Cold and Flu Tablets

For the relief of symptoms of common cold.

Combination of an antihistaminic, analgesic, antipyretic and oral decongestant.

Each tablet contains:

Acetaminophen	325 mg
Caffeine anhydrous	30 mg
Codeine phosphate	8 mg
Phenylephrine HCl	5 mg
Carbinoxamine maleate	3 mg

### INDICATIONS

Colds, acute rhinitis and allergic rhinitis, sinusitis, pyrexia, headache and allergic conjunctivitis. As an adjunct therapy in measles, rubella and chicken-pox.

### CONTRAINDICATION

Hypersensitivity to any of the components.

### DOSAGE

Adults : One tablet 3 or 4 times daily for 2 or 3 days. Treatment is most effective when started at the onset of symptoms. Never exceed the recommended dose.

### PRECAUTIONS

123<sup>®</sup> Cold & Flu tablets may cause drowsiness. Patients subject to this effect should avoid driving a car, operating intricate machinery, or doing work that requires fine precision. This preparation contains Codeine and should not be administered to children except on the advice of a physician.

**Keep out of the reach and sight of children.**

Care should be observed in the use of Codeine although tolerance and addiction to its use are rare.

In patients with severe respiratory depression, caution should be exercised if Codeine is administered. The respiratory depressant effect of Codeine may be enhanced by the concurrent administration of sedatives and tranquilizers.

As this medicine contains Codeine, it will add to the effects of alcohol and other medicines that slow down the nervous system, for example :

medicine for hay fever (antihistamines), tranquilizers, sedatives, narcotics, medicine for depression and anesthetics.

### DRUG INTERACTIONS

Please inform your physician of any medications you are taking, including those available without a prescription.

### PREGNANCY AND NURSING

If you are pregnant or are a nursing mother, please consult with your physician prior to using this medication.

### SIDE EFFECTS

Should any troublesome or unusual symptoms develop, a doctor should be consulted.

### PRESENTATION

Packs of 20 tablets.

### STORAGE CONDITIONS

Store in the original package. Do not store above 25°C.

Do not use after expiry date.
