## With Hydrocortisone Otic Drops

### COMPOSITION

## ACTION

Soothing preparation for pain and inflammation associated with minor infection or irritation. Polymixin B and Neomycin are antibiotics active against a wide variety of gram-positive and gram-negative pathogenic organisms. Aminacrine is bacteriostatic against organisms frequently implicated in ear, nose and throat infections. Benzocaine is a local anesthetic. Hydrocortisone is included to help reduce local inflammatory reactions.

## INDICATIONS

This product is indicated in certain diseases of the external ear canal, when complicated by infections carried by organisms sensitive to the antibacterial components of this product. It is recommended for use in localized neurodermatitis, seborrheic dermatitis, eczema and diffuse otitis externa (if eardrum is intact).

#### DOSAGE AND ADMINISTRATION

Instill two to four drops in the ear as directed by the physician.

Long term use should be avoided.

## CONTRAINDICATIONS

Hypersensitivity to any component of the medication. Tuberculous, fungal or viral infection of the external ear. Perforated eardrum.

## CAUTIONS

As with all adrenal corticosteroids, hydrocortisone sometimes may mask, activate or enhance infection. If infections do not respond promptly, this product should be discontinued until the infection has been adequately controlled by other measures.

The use of this preparation should be discontinued if any reaction indicating sensitivity is observed. Sensitivity to neomycin may develop, especially when it is applied to abraded skin.

The use of any antibiotic agent may result in the overgrowth of fungi or other nonsusceptible organisms, necessitating prompt medical attention for such new infection.

Long term use should be avoided.

#### SIDE EFFECTS

Should any troublesome or unusual symptoms develop, a doctor should be consulted.

## STORAGE CONDITIONS

Store in a dry place below 30°C, protected from light. Do not refrigerate.

Do not use after expiry date.
