HELICIDINE 10 ml

per 100 ml of syrup. Excipients: saccharose, glycerol, rasberry flavoured, parahydroxy methyl benzoate, sodic

parahydroxypropyl benzoat, purified water.

1 teaspoon contains 3.4 grams of saccharose.

1 tablespoon contains 10.3 grams of saccharose.

HOW TO USE THIS MEDICINE

Dosage

If no improvement is observed, do not increase the dose beyond that recommended and do not take any other cough mixture. Consult your doctor.

Usual dose is:

Adults: 2 tablespoons 3 times a day.

Children from 25 to 50 Kg (about 8 to 15 years of age): 3 to 5 tablespoons per day.

Children from 15 to 25 Kg (about 4 to 8 years of age): 1 tablespoon 3 times a day. Children under 4 years of age: Follow your

doctor's advice. THIS MEDICINE IS PROVIDED FOR YOUR PERSONAL USE FOR A SPECIFIC SITUA-
