

VENOSMINE® 450 mg, tablets

DIOSMIN

PHARMACO-THERAPEUTIC CATEGORRY

Bioflavonoids, capillary-protecting substances.

THERAPEUTICAL INDICATIONS

Symptoms due to venous insufficiency; conditions of capillary fragility.

CONTRAINDICATIONS

Hypersensibility to the active principle or to any of the excipients. Pregnancy and lactation.

PRECAUTIONS FOR USE

No particular precaution regarding the use of VENOSMINE is suggested.

INTERACTIONS

No particular interactions **has** been noticed so far. Inform your physician or chemist in case you have recently taken any other medicinal product, including non-prescription drugs.

SPECIAL WARNINGS

USE DURING PREGNANCY

Since the safety of the product during pregnancy has not been established, it is opportune not to administer it during pregnancy. Ask your physician or chemist before taking any medicinal product.

DOSAGE, ADMINISTRATION MODE AND TIME

1 tablet twice daily, at regular intervals, or according to medical prescription.

HOW TO USE IT

Tablets: Swallow down a tablet with little water.

Ask your physician or chemist necessary clarifications on how to use this medicinal product.

OVERDOSE

In case of accidental ingestion of an excessive dose of VENOSMINE, inform immediately your physician or go to the nearest hospital.

Should you have any doubt on the use of VENOSMINE, ask your physician or chemist.

UNDESIRABLE SIDE EFFECTS

Like any other medicinal product, VENOSMINE may cause undesirable effects although not all will show such effects. The use of VENOSMINE at the suggested therapeutical doses has rarely caused any side effect. However, rare cases of gastralgia, nausea, diarrhea, vertigo were reported although always of slight severity and not requiring the discontinuation of the treatment.

Sticking to the instructions contained in this leaflet reduces the risk of undesirable effects. Should any of the undesirable effects worsen or should an undesirable effect not listed in this leaflet occur, inform your physician or chemist.

EXPIRATION AND STORAGE

Expiration: see the expiry date on the outer package. The expiry date refers to the drug in its integral package, correctly stored. Attention: do not use the medicinal product after the expiry date on the outer package. Medicinal products must not be disposed of in the drain and in the household trash.

Keep out of reach and sight of children.

COMPOSITION

VENOSMINE 450 mg tablets

One tablet contains: *Active ingredient*: Diosmin 450 mg.

Excipients: Macrogol 4000 – Magnesium stearate (E572) – Talc – Anhydrous colloidal silica
