PHARMACO-THERAPEUTIC GROUP:

Progesterone is a progestational steroid.

THERAPEUTIC INDICATIONS:

1) Treatment of premenstrual syndrome, premenstrual tension and depression.

2) Treatment of puerperal depression.

3) Indicated for the supplementation of insufficient secretion of progesterone in women participating in fertilization

programs.

ACTIVE AND INACTIVE INGREDIENTS AND THEIR QUANTITIES:

Each pessary contains as active ingredient 200 mg and 400mg progesterone.

Inactive ingredient: Vegetable fat.

CONTRA-INDICATIONS:

Undiagnosed vaginal bleeding.

PRECAUTIONS:

Use vaginally if patients suffer from colitis or faecal incontinence.

Progesterone is metabolized in the liver and should be used with caution in patients with hepatic dysfunction. Gesta contains the hormone progesterone which is present in significant concentrations in women during the second half of the menstrual cycle and during pregnancy. This should be borne in mind when treating patients with conditions that may be hormone-sensitive.

INSTRUCTIONS FOR PROPER USE

DOSAGE

Adult: 200 mg daily to 400mg twice a day, by vaginal insertion. For premenstrual syndrome commence treatment on day 14 of menstrual cycle and continue treatment until onset of menstruation. If symptoms are present at ovulation commence treatment on day 12.

For fertilization support purposes 200mg inserted into the vagina daily but can be increased to 400mg twice daily.

THE METHOD AND ROUTE OF ADMINISTRATION

For vaginal insertion.

DURATION OF TREATMENT

Individually, see the dosage

There is a wide margin of safety with Gesta® pessaries, but overdosage may produce euphoria or dysmenorrhoea.

ACTION TO BE TAKEN WHEN ONE OR MORE DOSES HAVE NOT **BEEN TAKEN:**

The patient should continue the treatment as prescribed.

INDICATION-THE RISK OF WITHDRAWAL EFFECTS: None

UNDESIRABLE EFFECTS:

Menstruation may occur earlier than expected, or, more rarely menstruation may be delayed.

As with other vaginal preparations, some leakage of the pessary base may occur.

STORAGE CONDITIONS:

Store below 25°C in dry place.

Do not use the medicine.
