



Attention, read carefully

Allergodil[®] Nasal Spray

Active ingredient: Azelastine hydrochloride

Composition

Each spray puff (equivalent to 0.14 ml solution) contain 0.14 mg Azelastine hydrochloride

Other ingredients:

Sodium edetate, Methylhydroxypropyl cellulose, Dehydrated citric acid, Sodium phosphate, Sodium chloride, purified water.

Indications

For symptomatic treatment of seasonal allergic rhinitis (hay fever) or nonseasonal (perennial) allergic rhinitis.

Contraindications

Allergodil must not be used in patients with known hypersensitivity to azelastine hydrochloride, EDTA, nor in children under 6 years of age.

Usage in pregnancy and lactation

Although doses far in excess of the therapeutic range tested in laboratory animals failed to generate any evidence of teratogenic effect of the drug, current medical concepts discourage use of allergodil in the first trimester of pregnancy.

Allergodil should not be used by nursing mothers, because there is insufficient evidence of the safety of the drug during lactation.

Side-effects

In rare cases irritation of the inflamed nasal mucosa can occur on spraying, e.g. stinging, itching and sneezing. In isolated cases patient can experience nosebleeding. Improper administration (with head reclined back; see Dosage instruction and mode of use) may produce a bitter taste which may lead occasionally to nausea.

Interactions with other drugs

None known.

Dosage instruction, how to use and duration of therapy

Unless otherwise prescribed, spray once into each nostril twice daily (equivalent to a daily dose of 0.56mg Azelastine hydrochloride). Spray with head held upright (see how to use Allergodil)

Allergodil may be used until symptoms clear up, but treatment should not be continued for more than 6 consecutive months.

Stability note

Store below 25°C / Do not refrigerate Do not use after the expiration date shown on the package.

Do not use longer 6 months after bottle was first opened.

Store drugs out of children's reach!

- 4- Wipe and return the head cover


