ATC code: N03AX16. The active substance, Pregabalin, is a gamma-aminobutyric acid analogue ((S)-3-(amino-methyl)-5-methylhexanoic acid). Pregabalin indis to an auxiliary subunit (a,-5 protein) of voltage-gated calcium channels in the contral nervous system, potently displacing [⁷H]-gabapentin. Pharmacotivenic Properties Pharmacotivenic teroperties Pregabalin isteady-state pharmacokinetics are similar in healthy volunteers, patients with epilepsy receiving anti-epilepic drugs and patients with chronic pain. <u>Absorption</u>: Pregabalin is rapidly absorbed when administered in the fasted state, with peak plasmia concentrations occurring within 1 hr following both single and multiple dose administration. Pregabalin absorption is decreased when given with food resulting in a decrease of c_m by approximately 25-30% and a delay in T_{ma} to approximately 2.5 hrs. However, administration of Pregabalin with food has no clinicilly significant effect on the extent of Pregabalin absorption. to plasma proteins." <u>Metabolism</u>: Pregabalin undergoes negligible metabolism in humans. Following a dose of radiolabelled Pregabalin, approximately 98% of the radioactivity recovered in the urine was unchanged Pregabalin. The N-methylated derivative of Pregabalin, the major metabolite of Pregabalin found in urine, accounted for 0.9% of the dose. In preclinical studies, there was no indication of racemization of Pregabalin S-enantiomer to the R-enantiomer. <u>Elimination</u>: Pregabalin is eliminated from the systemic circulation primarily by renal excretion as unchanged drug. Pregabalin mean elimination half-life is 6.3 hrs. Pregabalin plasma clearance and renal clearance are directly proportional to CL. Dosage adjustment in patients with reduced renal function or undergoing haemodialysis is necessary.

Since Pregabalin does not undergo significant metabolism and is excreted predominantly as unchanged drug in the urine, impaired liver function would not be expected to significantly alter Pregabalin plasma concentrations. INDICATIONS Neuropathic pain: Pregaforte[®] is indicated for the treatment of peripheral and central neuropathic pain in adults. <u>Epilepsy:</u> Pregaforte[®] is indicated as adjunctive therapy in adults with partial seizures with or without secondary generalisation. <u>Generalised Anxiety Disorder</u>: Pregaforte[®] is indicated for the treatment of Generalised Anxiety Disorder (GAD) in adults. **CONTRAINDICATIONS**

In accordance with current clinical practice, some diabetic patients who gain weight on Pregabalin treatment may need to adjust hypoglycaemic medications. Pregabalin treatment may need to adjust hypoglycaemic medications. Pregabalin treatment has been associated with dizziness and somnolence, which could increase the occurrence of accidental injury (fall) in the elderly population. There have also been post marketing reports of loss of consciousness, confusion and mental impairment. Therefore, patients Cases of renal failure have been reported and discontinuation of Pregabalin did show reversibility of this adverse effect. After discontinuation of short-term and long-term treatment with Pregabalin withdrawal symptoms have been observed in some patients. The following events have been mentioned: insomnia, headache, nausea, diarrhoea, flu syndrome, nervousness, depression, pain, swealing and dizziness. The patient should be informed about this at the start of the treatment. There have been post-marketing reports of congestive heart failure in some patients receiving Pregabalin.

There have been post-marketing reports of congestive heart failure in some patients receiving Pregalalin. Patients with rare hereditary problems of galactose intolerance, the Lapp lactase deficiency or glucose-galactose malabsorption should not take this medicine. Suicidal ideation and behaviour have been reported in patients treated with anti-epileptic agents in several indications. A meta-analysis of randomised placebo controlled trials of anti-epileptic drugs has also shown a small increased risk of suicidal ideation and behaviour. The mechanism of this risk is not known and the available data do not exclude the possibility of an increased risk for Pregabalin. Ability to drive and use machines. Patients are advised not to drive, operate complex machinery or engage in other potentially hazardous activities until it is known whether this medication affects their ability to perform these activities. **PREGNANCY AND LACTATION**

PREČNÁNCY AND LACTATION There are no adequate data on the use of Pregabalin in pregnant women. Studies in animals have shown reproductive toxicity. The potential risk to humans is unknown. Pregabalin should not be used during pregnancy unless clearly necessary (if the benefit to the mother clearly outweighs the potential risk to the focus). Effective contraception must be used in women of child bearing potential. It is not known if Pregabalin is excreted in the breast milk of humans; however, it is present in the milk of rats. Therefore, breast-feeding is not recommended during treatment with Pregabalin. DRUG INTERACTIONS Since Pregabalin is predominantly excreted unchanged in the urine, undergoes negligible metabolism in humans (<2% of a dose recovered in urine as metabolites), does not inhibit drug metabolism in ivitro, and is not bound to plasma proteins, it is unlikely to produce, or be subject to, pharmacokinetic interactions.

Accordingly, in in vivo studies no clinically relevant pharmacokinetic interactions were observed between Pregabalin and phenytoin, carbamazepine, valproic acid, lamotrigine, gabapentin, lorazepam, oxycodone or ethanol. Population pharmacokinetic analysis indicated that oral antidiabetics, divurtics, insulin, phenobarbital, tiagabine and topiramate had no clinically significant effect on Pregabalin clearance. Co-administration of Pregabalin with the oral contraceptives norethisterone and/or ethinyl oestradiol does not influence the steady-state pharmacokinetics of either substance. Pregabalin may potentiate the effects of ethanol and lorazepam. In controlled clinical trials,

multiple oral doses of Pregabalin co-administered with oxycodone, lorazepam, or ethanol did not result in clinically important effects on respiration. In the postmarketing experience, there are reports of respiratory failure and coma in patients taking Pregabalin and other CNS depressant medications. Pregabalin appears to be additive in the impairment of cognitive and gross motor function caused by oxycodone. **ADVERSE EFFECTS** The Pregabalin clinical programme involved over 9000 patients who were exposed to Pregabalin, of whom over 5000 were in double-blind placebo controlled trials. The most commonly reported adverse reactions were dizziness and somolence. Adverse reactions were usually mild to moderate in intensity. In all controlled studies, the discontinuation rate due to adverse reactions was 13% for patients receiving Pregabalin and 7% for patients receiving placebo. The most common adverse reactions were in the induction from Pregabalin treatment groups were dizziness and somolence. Pregaforte® may be taken with or without food. <u>Neuropathic pain</u>: Pregaforte® rearment can be started at a dose of 150 mg/day. Based on individual patient response and tolerability, the dosage may be increased to 300 mg/day after an interval. <u>Enjepsy</u>: Pregaforte® treatment can be started with a dose of 150 mg/day. Based on individual patient response and tolerability, the dosage may be increased to 300 mg/day after an interval. <u>Enjepsy</u>: Pregaforte® treatment can be started with a dose of 150 mg/day. decreased renal function. Hepatic impairment: No dosage adjustment is required for patients with hepatic impairment. Renal impairment: Pregaforte[®] is eliminated from the systemic circulation primarily by renal excretion as unchanged drug. As Pregaforte[®] clearance is directly proportional to Cl₂, dosage reduction in patients with compromised renal function must be individualised according to Cl₂, as indicated in Table 1. Pregaforte[®] is removed effectively from plasma by haemodialysis (50% of drug in 4 hrs). For patients receiving haemodialysis, the Pregaforte[®] daily dose should be adjusted based on renal function. In addition to the daily dose, a supplementary dose should be given immediately following every 4-hr haemodialysis treatment (see Table 1). Table 1. OVERDOSAGE

OVERDOSAGE In overdoses up to 15 g, no unexpected adverse reactions were reported. In the post-marketing experience, the most commonly reported adverse events observed when Pregabalin was taken in overdose included somnolence, confusional state, agitation, and restensess.
